



INFORMATION ON THE PLANNED DIVISION OF PRESS GLASS SA

Ladies and gentlemen,

Please be informed that on December 1st 2021, Press Glass SA will be divided pursuant to the provisions of Art. 529 1 pt. 4 et seq. CCC through the transfer of a part of the enterprise in the form of four production branches located in Radomsko, Tychy, Tczew and Miętno to a newly established limited liability company Press Glass Sp. z o. o.

After the division, Press Glass SA will continue its holding and financial activity under the name of Press Glass Holding SA.

After the division, the newly established company Press Glass Sp. z o.o. will continue the production activity, hitherto conducted by Press Glass SA, in the field of IGU's production and sales. The existing branch offices of Press Glass SA will become branches of Press Glass Sp. z o.o.

According to the demerger plan, the new company will also include rights and obligations resulting from our cooperation so far, which means that receivables and liabilities incurred prior to the demerger will be taken over by the newly established Press Glass Sp. z o.o.

SUPPLIERS:

As of the date of registration of the division, i.e. as of December 1st 2021st, invoices for the supplies of raw materials to production divisions have to be issued to the newly established Press Glass Sp. z o.o. according to the place of delivery.

RECIPIENTS:

After 01.12.2021 the deliveries will be documented by invoices issued by relevant branches of Press Glass Sp. z o.o.

We will provide Press Glass Sp. z o.o. with a new NIP number immediately after the registration of the company in KRS (National Court Register).
